**MOTION TO ADOPT RESOLUTION #2018-22: A RESOLUTION SETTING THE MILLAGE RATE FOR 2018 AD VALOREM TAXES**

**Council Member Watts made a motion to adopt Resolution #2018-22: A Resolution setting the millage rate for ad valorem (property) taxes for the 2018 calendar year for the City of Sandersville, Georgia. Council Member Brown seconded and the motion passed unanimously. (Attachment B)**

**MOTION TO ADOPT RESOLUTION #2018-23: A RESOLUTION TO SUPPORT THE EXTENSION OF INTERSTATE 14**

**Council Member Brown made a motion to adopt Resolution #2018-23: A Resolution to support the extension of Interstate 14 through Sandersville, Georgia. Council Member Davis seconded and the motion passed unanimously. (Attachment C)**

**MOTION TO AWARD A BID FOR MILLING & RESURFACING A SECTION OF SOUTH HARRIS STREET**

**Council Member Watts made a motion to award a bid to the only responsive bidder, C&H Paving, in the amount of \$24,999.99 for milling and resurfacing a section of South Harris Street. Council Member Davis seconded and the motion passed unanimously. (Attachment D)**

**MOTION TO AUTHORIZE A ONE-TIME DISCOUNT TO EAST HAYNES STREET UTILITY CUSTOMERS**

**Council Member Brown made a motion to authorize a one-time discount of 25% to East Haynes Street utility customers affected by the**

street construction. Council Member Watts seconded and the motion passed unanimously.

**MOTION TO TABLE APPOINTMENT FOR TREE BOARD**

**MOTION TO AWARD A BID FOR INSTALLATION OF UNDERGROUND ELECTRIC SERVICE FOR THE EAST HAYNES STREET IMPROVEMENT PROJECT**

Council Member Brown made a motion to award a bid to the lowest responsive bidder, U-Tec in the amount of \$24,650.00 for the installation of underground electric service for the East Haynes Street improvement project. Council Member Davis seconded and the motion passed unanimously.
