APPROVAL OF COUNCIL MEETING MINUTES

Council Member Watts made a motion to approve the minutes of the July 1, 2019 and the July 15, 2019 joint meeting of the City Council as presented. Council Member Davis seconded and the motion passed unanimously. (Attachment A)

MOTION TO REJECT A BID TO PITTMAN CONSTRUCTION FOR THE MILLING AND RESURFACING PROJECT IN THE AMOUNT OF \$264,100 AND AUTHORIZE TO REBID THE PROJECT.

Council Member Brown made a motion to reject the bid to Pittman Construction for the milling and resurfacing project in the amount of \$264,100 and authorize to rebid the project. Council Member Davis seconded and the motion passed unanimously. (Attachment B)

MOTION TO AUTHORIZE THE PAYMENT OF AN INVOICE TO WRIGHT & WRIGHT, P.C. IN THE AMOUNT OF \$28,900 FOR AUDIT OF FINANCIAL STATEMENTS FOR YEAR ENDED DECEMBER 31, 2018.

Council Member Davis made a motion to authorize the payment of an invoice to Wright & Wright, P.C. in the amount of \$28,900 for audit of financial statements for year ended December 31, 2018. Council Member Watts seconded and the motion passed unanimously. (Attachment C)

MOTION TO ADOPT RESOLUTION 2019-15 TO PROVIDE FOR THE ISSUANCE OF THE CITY OF SANDERSVILLE WATER AND SEWER REVENUE BOND, SERIES 2019A, IN THE PRINCIPAL AMOUNT OF \$12,792,000, AND THE SERIES 2019B IN THE PRINCIPAL AMOUNT OF \$2,488,500.

Council Member Davis made the motion to adopt Resolution 2019-15 to provide for the issuance of the City of Sandersville Water and Sewer Revenue Bond, Series 2019A, in the principal amount of \$12,792,000. And the series 2019B in the principal amount of \$2,488,500.

Council Member Brown seconded and the motion passed unanimously. (Attachment D)

MOTION TO AUTHORIZE SPEED BUMPS TO BE PUT ON DANIELS STREET.

Council Member Watts made a motion authorize speed bumps to be put on Daniel Street. Council Member Brown seconded and the motion passed unanimously.
